


Information on 2017 GEI International Conference Series

New Opportunities and Development of Global Infrastructure Connectivity

On September 26, 2015, Chinese President Xi Jinping proposed discussions on establishing GEI at the UN Sustainable Development Summit. During the G20 Hangzhou Summit held in September 2016, China proposed the establishment of the Global Infrastructure Connectivity Alliance, which proves again that promoting energy infrastructure connectivity has become the consensus of all sides. The decade to come is crucial to the implementation of projects related to the development of clean energy, grid interconnection and smart systems which will witness the taking-off of the development of cross-border and intercontinental power transmission lines.

2017 International Conference on Global Energy Interconnection will provide a high-level platform for participants to exchange ideas, discuss issues of common concern and share development results through keynote speeches, the release of the latest research results, roundtables, professional forums and banquets. It will gather the best minds of countries, industries and sectors all over the world to make concerted efforts to push forward the development of GEI.

Major topics:

- International cooperation: the development of GEI requires global consensus and efforts. The conference will promote global cooperation in organizational construction, multilateral consensus, working mechanisms and financial support to establish a GEI cooperation system that covers all areas on all levels.
- Grid development: grid development is the key to the construction of GEI. Therefore, the conference will locate major cross-border and intercontinental interconnection projects that are ready for and in urgent need of development with reference to the realities of the power industry in regions of strategic importance, and work together to push for their implementation.
- Cutting-edge technologies: technological innovation is the major driver of GEI. Therefore, the conference will explore the trend of energy and electricity technologies, release the latest research results and promote technological exchanges and sharing.
- Industrial innovation: the conference will hold discussions on new industries of future GEI to find new drivers for world economic growth with a special focus on the industrial chain of the power
- Finance and investment: GEI will bring with it huge investment opportunities. Therefore, the conference will explore new business models covering energy production, transmission and consumption to provide competitive financial solutions to global energy and electric power development.

Seek for Future Energy Interconnection in Europe Together

The development of GEI is of crucial importance to guarantee social and economic development and energy supply in Europe, a major global power load. In recent years, EU has been vigorously supporting the development and use of clean energy, and actively promoting intracontinental grid interconnection with significant progress in the development of clean energy. Against such background, the transition to a more diversified energy supply model that covers a larger area has become the focus of European countries and the international community as well.

Major topics:

- The development strategy of GEI in Europe: find the landing point to integrate GEI concept with European grid development plans; transmit clean energy from afar to the socio-economic center in Europe via constructing cross-regional and intercontinental interconnected power arteries based on the energy endowment and grid layout in Europe.
- Future European energy market in the context of GEI: in-depth analysis will be made on the transition of European energy market in the context of GEI in relation to energy policies, financial support, energy market regulation and trade mechanism in Europe.
- Case studies of European grid interconnection and their revelation: European countries have rich experience in constructing and operating cross-border grid interconnection projects, which is a significant advantage in the development of GEI. Case studies of European grid interconnection projects can provide practical solutions to GEI and create a favorable environment for the implementation of more transpational interconnection projects.

How to integrate GEI into the development of the Belt and Road Initiative.

- Grid development: study key areas of grid interconnection in Africa, explore into the technological and engineering feasibility of joint operation of solar and wind power bases in North Africa, hydropower bases in Central Africa, and solar power bases in South Africa.
- Innovation in financing and business models: explore the construction of financing and investment channels for GEI to fully tap the potential of energy interconnection in Africa in an attempt to realize win-win business mode, reduce investment risks, promote the development of renewable energy and push for a leapfrog development of the economy, society and the energy industry in Africa.





The 2016 International Conference on Global Energy Interconnection themed as "To Meet the Global Power Demand with Clean and Green Alternatives" was held in Beijing from March 30 to 31, 2016. More than 800 representatives from 300 entities of international organizations such as the UN and of government organs, industrial organizations, companies and scientific research institutes and universities from 26 countries in Asia, Europe, Africa, America and Oceania attended the conference.
